President Report**

- Eileen Cichocki has a change in title to Assistant Superintendent/Vice President of Administrative Services.
- The college is currently working with student equity to do work with race and ethnicity and directly looking at numbers of student success and how the college staff can help students to be more successful.
- Housing for the football players continues to be an issue. The old Howard Hospital in Willits is under consideration for student housing, however the building needs to be brought up to current building codes and those improvements are costly.
- The college is looking at open source textbooks, so students have a free and more accessible option.
- Reyes is requesting that the Board of Trustees adopt a sanctuary resolution at the college to ensure the safety and protection of all members of the community, especially those vulnerable to immigration enforcement. He indicated it is our responsibility to create an environment where all of our students feel safe and secure. The district will follow the State and Federal laws pertaining to the sanctuary resolution.

**Marketing update.**

- **Appeal letter.** An appeal letter was mailed in late November. We have received \$1,450 in donations to date.
- **Newsletter.** The fall newsletter was mailed in early November and highlighted the redesigned website.
- **Giving Tuesday fundraiser.** On Tuesday, November 29 the Foundation raised money for the Mendocino College Food Pantry during the national day of giving known as #GivingTuesday. We exceeded our \$1,000 goal with a total of \$3,009 in donations.
- **TI-84 calculators for North County campus.** The Foundation funded TI-84 calculators for the North County campus which were purchased at a discounted rate from the Mendocino College bookstore. Students who cannot afford to purchase one can check out the calculators to use in class.
- **2016 Holiday Trolley.** The Foundation and the college are co-sponsoring Ukiah's Holiday Trolley. Our trolley stop is at the Alex Thomas Plaza.
- **Emeritus event.** The annual emeritus event is scheduled for Wednesday, February 8.
- **Scoreboard – football/soccer field.** A proposal was submitted to Community First Credit Union to fund the purchase of a new scoreboard for the football/soccer field.
- **Rural Health Rocks fundraiser – April 29, 2017.** The event will be held at Cotton Auditorium in Fort Bragg featuring Michael McDonald.
- **News releases.** The most recent news releases were provided for information.
- **Mendocino College student holiday meal.** Students were provided a free holiday meal on Tuesday, December 6 which was hosted by the Associated Students and the College Management Group.
- **Adopt a Fifth Grader presentations.** Presentations have been provided to various service clubs in the area in an effort to raise awareness and generate sponsors.

**Coastal development.** Two fundraisers are planned for 2017. Development Director

Kvinsland recruited sponsors for five Adopt a Fifth Graders last year. This year to date she has recruited sponsors for 14 students.

**Professional development.** The Foundation staff participated in a Giving Tuesday webinar which provided the incentive to do a Giving Tuesday event. Fairbairn is always looking for other developmental tools for the Foundation staff.

**Holiday dinner.** The annual holiday dinner is on December 13 at Dora's Gourmet Café.

**College of the Redwoods scholarship funds.** Assistant Superintendent/Vice-President of Administrative Services Cichocki anticipates receiving the scholarship funds from College of the Redwoods in the next few weeks.
